Course Title: Science Independent Study

Length of Course: 7 - 30 cycles

Grade Level(s): 10 - 12 Periods Per Cycle: 3 - 6

Units of Credit: Increments of .25 Credits Length of Period: 43 minutes

Classification: Elective Total Instructional Time: approximately 30-120 hours

Course Description

Science Independent Study is a course that allows students to design a proposal that explores topics of interest relating to scientific concepts and inquiry that extends beyond the science curriculum. Once approved, the students will work with instructors to experience meaningful learning that is highly engaging, fosters exploration and creativity, and expands their knowledge in science. The students will be required to produce a portfolio or equivalent project.

This course may not replace any existing course curriculum and requires teacher and administration approval.
